* Overview of Temporary memberships

Purpose of creating new Temporary memberships

- The Management Committee acknowledges that there has been a large difference in the usage that Members have had of the Club facilities over the past 12 months
- In addition, at the time of proposing the subscriptions for the next 12 months, there are still significant restrictions in place on using the full Club facilities in particular for Members who play squash or use the gym facilities
- The newly created Temporary memberships are for a period from 1 April 2021 until 30 June 2021, at which point
 these will be reviewed. The Management Committee will consider the level of restrictions still in place as well as the
 number of Temporary Members
- During this period, Temporary Members will be able to use all Club facilities other than the tennis facilities (inc squash, gym and bar). Temporary Members will not have full voting rights during General Meetings.

Eligibility criteria for new Temporary memberships

- The Temporary memberships have been created to cater for existing Members who:
 - o have had their use of the Club facilities wholly or very severely restricted over the past 12 months;
 - o do not intend to use the tennis facilities for the period to 30 June 2021 (as Member or Guest); and
 - o would want to resume their full membership when the current restrictions are lifted

Process for switching to Temporary memberships

- The Management Committee has been overwhelmed by the support shown by Members to the Club over the past 12
 months and we acknowledge that a number of Members have been happy to continue to financially support their Club
 in spite of the reduced availability of facilities.
- We would be delighted if Members who have had their use of facilities restricted but are in a position to continue to support their club by renewing as full Members would do so. This will put your Club in the strongest possible position to emerge from these restrictions in a positive position.
- However, we fully understand that some Members will no longer feel that they are able to commit to paying the full
 Membership subscription at the current time. Our aim is to do what we can to retain these Members as a part of the
 Club in the long term, so if any Member feels they are in this position then we would want to hear from you.
- We would ask that existing Members who would like to switch to a Temporary membership to contact Reception to briefly outline their circumstances and confirm that they are eligible, based on the above criteria.
- We appreciate that every individual circumstance will be different and we will look to apply these rules in as fair and transparent a way as possible for the benefit of all Members.
